Robert Behrendt has completed the Leadership Arts Program sponsored by the North Texas Business for Culture and the Arts.

Executive and Employment Matters

Kilgore settled 40 employment cases in 2008, representing a revenue increase of 48 percent from employment cases. Many of these were resolved in a matter of weeks. Kilgore represented CEOs and executives from a variety of enterprises including a chip manufacturing and equipment supply business, a bank, a national dry cleaning company, an oil and gas investment firm, a public lottery business, and an international building company. Kilgore also represented physicians in partnership disputes and Merritt Hawkins, a health care oriented personnel provider, in defense of a class action overtime case. Kilgore represented workers from protected classes who were discriminated or retaliated against. In connection with the cataclysmic changes in the economy, Kilgore represented brokers from Bear Stearns, Lehman Brothers, and UBS as well as traders from TXU. At the same time, he always left an opening, that if they were interested in a fair and equitable settlement, we were open to that, as well.
